policy (subjected to change)

**terminology:**

**alternative specials: is a newer terminology being implemented by us derived from the term “alter normative” which has also begun being used. we feel that a newer term to describe people who have been seen and who also may assign as disabled was more than necessary. with much conversation being debated for centuries on the negative associations of disability terms and with disability rights organizations constantly fighting to get persons to have pride with using the word, we wanted to begin to hone the word alternative special beings/persons. it helps broaden the idea of what it means to be different without connotation of it being and having a negative effect. or at least we hope so. though we do not know who created the term alter normative we do liken our phrase alternative special to being more free and more inept to the times where people who are disabled can still awaken to their own celestial powers & confidence.**

returns: if for some reason you do not like your item you can return your item by sending to the defaulted print facility where they then have the ability to send to us. all items can be returned within 30 days according to their policy. we may use different facilities at any given time and therefore we reserve the right to change this policy.
